CV Nicholas Teller – CEO E.R. Capital Holding GmbH & Cie. KG

Nicholas Teller, born in 1959 in London, Great Britain, is the Chief Executive Officer of the E.R. Capital Holding GmbH & Cie. KG. He was educated in Düsseldorf, Germany and studied Commerce at the University of Birmingham in the U.K.

He joined Commerzbank in London in 1982 where he worked for twelve years before becoming Head of Commerzbank in Prague in 1994. In 1999 he was appointed General Manager of the Bank for the Hamburg region, where he was responsible for the group's shipping business, both as a regional board member and as head of the Northern German, Scandinavian and Eastern European regions. In April 2003 Nicholas Teller was appointed to Member of the Board of Managing Directors of Commerzbank AG Frankfurt with prime responsibility for the Corporates and Markets Division (Investment Banking).

Until 2008 Teller was also Supervisory Board Chairman of Deutsche Schiffsbank AG, a leading ship financing bank. With effect as of 1 August 2008 Nicholas Teller has been appointed the new CEO and partner in E.R. Capital Holding GmbH & Cie. KG.

Background to company

E.R. Capital Holding is the sole shareholder of the following companies:

Nordcapital
