  1. Companies/professionals with less than 20 employees: 350 Euro p. a.
  2. Companies with 20 or more employees: 800 Euro p. a.
  3. Sustaining members (in addition to their ordinary subscription fee): 950 Euro p. a. (minimum)
  4. Students on production of a student identity card: 100 Euro p. a.
  5. Former managing directors or representatives of corporate members: 100 Euro p. a.
  6. New members who are individuals not working for any company or who are running small companies with less than 5 employees (companies shall here mean „start-ups“ and include groups of self-employed persons) 200 Euro p. a. for the first two years and 350 Euro p.a. thereafter.
  7. Branches -apart from those of sustaining members- in addition to the head office subscription): 150 Euro p.a.
9. Amendment of the statutes: Article 15 Para.4:  
The Regional Committee elects a chairman, a proxy and a treasurer for a term of two years, with majority vote.  
Re-election is possible. After the second re-election of the chairman, his proxy and the treasurer, a majority vote of 75% is necessary.
